Center for Terrorism Law

Monthly Activity Report

March 2009

1. The Center for Terrorism Law is conducting a national symposium to be held 30 April – 1 May 2009 in Houston, Texas, to provide information on how to develop appropriate security methods and procedures to mitigate a business' potential legal liability in the event of acts of terrorism or crime. The symposium is entitled: ***Terrorism, Crime & Business: Understanding the Fundamental Legal and Security Liability Issues for American Business.*** See www.stmarytx.edu/ctl for additional details. Seating is limited to 195, but room is still available. The three keynote speakers are United States Congressman Mike McCaul, 10th District, Texas; Wade M. Battles, Interim Executive Director, Port of Houston; and distinguished attorney Martin D. Beirne. The topics covered include:

- An overview of the aims and objectives of the global terror threat posed by al-Qaeda-styled terror groups, sub-state terror groups, and “lone wolf” terrorists.
- An analysis of the specific threats to American business sectors that are deemed part of the nation’s “critical infrastructure,” i.e. energy, petro-chemical, electric utilities, communication, transportation, health, etc.
- An understanding of the varied legal issues associated with terrorism and criminal negligence claims against businesses that have suffered a terror attack or serious criminal act in cyberspace or the physical world.
- A comprehensive review of how to develop appropriate security methods and procedures to mitigate business' potential legal liability.

2. The fifth annual ***Terrorism Seminar 2009: Preparing Law Enforcement for Threats to National Security*** was held at St. Mary's University School of Law from 9-12 March 2009. Over 200 law enforcement and military personnel from across the United States attended this year's conference.

3. The Center for Terrorism Law continues to coordinate with the American Embassy Kuwait regarding the development of a university level (for academic credit) course at the American University Kuwait on legal and policy matters related to terrorism. The tentative date for the Kuwait based event is early 2009. Dr. Rawda Awwad, a professor at the American University of Kuwait, visited the

Center for Terrorism Law on 12-13 December 2008 and met with Center for Terrorism Law research fellows and the Director to develop materials on the legal issues for the course.

4. The Center for Terrorism Law submitted an Amicus Curiae brief to the Supreme Court of the United States in the case of *Iraq v. Simon, et al.* The case regards issues associated with the torture of American military personnel in the 1991 Gulf War. Center for Terrorism Law research fellows who worked on the brief were Miguel Dilley (team leader), Keith McMahon, Kris Rivenburgh, and Byron Miller.

5. The law review article entitled: *The Political Question Doctrine and Civil Liability for Contracting Companies on the "Battlefield,"* by Professor Addicott was published in March 2009 at 28 of *The Review of Litigation* 343 (2008).

6. The Center for Terrorism Law continues to coordinate cyber training initiatives with the Center for Infrastructure Assurance and Security (CIAS) at the University of Texas San Antonio.

7. Visiting Professor of Law, University of Texas School of Law, Robert M. Chesney will deliver the Center for Terrorism Law's 2009 Distinguished Speaker address on 23 April 2009 at St. Mary's University School of Law. Professor Chesney will speak on the use of federal courts to prosecute Islamic terrorists from GITMO.

8. The Center for Terrorism Law is working on an affidavit in a civil action regarding the 2000 torture of two Israeli soldiers by Palestinian police.

9. The Center for Terrorism Law is working on an affidavit in an administrative case involving the application of the Geneva Conventions to interrogation of suspected Taliban enemy combatants.
