Administrative History

During his presidency, Walter Buehler (1950-1961) established the vice-presidencies for academics, and for development and finances along with the “Office of Civic [Public] Relations.” Over the years the vice president for academics position has had several name changes. Its title at the time of its creation was actually “Dean of the University” (March 4, 1957). In the fall of 1958, the position was called “Vice President of Academic Affairs-Dean of the Faculties” (September 1958). This was later shortened to Vice President, Dean of Faculties.” The title Vice President for Academic Affairs was in use in the early 2000s. During 2017 the office was renamed Provost. According to an early job description (December 20, 1974), the “Vice President-Dean of Faculties” was “the first among equal Vice Presidents in the absence of the President.” “His primary concern is with the educational program. He is occupied for the most part with the administration of existing policy which has been established by the President and the Board of Trustees.” The Academic Council is an advisory body that is intended to assist the Vice President in the execution of his office. The vice president for academics is directly responsible to the president for the conduct of the educational function of the University and renders a semi-annual report concerning it.

Subgroup Overview

The records of the office of Vice President for Academics begin in 1957. The records of the Academic Council begin in 1932 and the continuous series of Faculty Meeting minutes begins in 1947 and extends to 2009. Record series that were maintained continuously beyond the tenure of a single vice president are arranged under the title “General Series.” Otherwise, records that pertain to the administration of a single vice president appear under that person’s name. The vice president for academics effectively ran the internal aspects of the educational program of the university. This included what courses to offer, which to require, the evaluation of the general effectiveness of the curriculum, the supervision of teaching, the giving of grades, and the development of new curriculum.

Administrative History Note: This series of reports began as the “Dean’s Report to the President.” Eventually it became known in common parlance as “Semi-Annual Reports to the President.” Finally, it shifts to and “End of the Year Assessment Report.”

Scope: The vice president for academics is directly responsible to the president for the conduct of the educational function of the University and rendered a semi-annual report concerning it. In preparation for the report, each unit involved with instruction submitted a departmental report.

Academic Council, 1932-2010

Administrative History Note: This council consists of the Academic Vice President and the Deans of the various schools. The records for this council date back to January 10, 1932, at which time the president of the university was the chairman of the council since the position of Vice President for Academics did not yet exist. Brother Fred J. Junker was the original secretary of the council until February 1938. Brother Thomas Treadaway became secretary in December 1938 and remained so until May 1957. His leadership role is suggested by an entry in the minutes dated October 15, 1946 which begins “The scope of the jurisdiction of the Academic Council is the same as that of the Dean-Registrar.” It continues with the statement that, “Members [of the Academic Council] are nominated by the Dean-Registrar, appointed by the President.” In October 1957, the Dean of Faculties assumed leadership of the council and responsibility for secretarial services.

Academic Council Minutes, 1932-2010

Arrangement Note: There are two sets of minutes for the Academic Council: a reading copy in the stacks and a security copy in the vault. In 2020, the reading copy was rehoused in uniform binders to facilitate use by researchers whereas the security copy is housed in various sizes of binders. The length of the minutes varies greatly from year to year so that some years continue through one binder to the next. The hardcopy version of the Academic Council Minutes ends in 2010 indicating that born-digital records replaced them in that year.

Processing Note: From the Annual Report for 1997-1998 by Brother Robert Wood, SM: “The first and biggest ‘in-house’ project was to try to make two complete sets of the Minutes of the Board of Trustees, the Executive Council, the Academic Council and the Faculty Senate from the beginning of each entity to 1995. With help from Melba Fisher, Connie Cano, Homer Fetzer and Bob O’Connor I was able to achieve about 95% of this goal. The Faculty Senate binders also contain correspondence, committees, resolutions, etc. This project took close to three months.”

Access Note: Use the reading copy for researchers. The security copy in the vault is difficult of access and not uniform in housing.

Academic Assessment, 1988-2003

Administrative History Note: “Academic Assessment” refers to the measurement of “institutional effectiveness” by defining goals, then evaluating the degree of attainment of these goals, and finally, using the data accumulated to change programs and services. The organized pursue of “assessment” began in 1988 led by Doctor Gerry Dizinno that applied to some academic departments. However, for the 1992-1993 self-study for SACS accreditation the assessment process was extended to all academic departments and programs. The university hired a Director of Academic Assessment after 1992, the first being Cynthia Olney.

Arrangement Note: Keep in mind that for a period of time, each faculty member was obliged to submit an End of the Year Assessment Report about one’s teaching skills with a plan for improvement during the coming year. These were distinct from the departmental or school assessment reports.

Continuing Education Program, 1954-2008

Historical Note: Continuing education at St. Mary's University began as "Adult Education" during the 1950s and developed into a "Community Services Program" during the 1960s and then as a "School of Continuing Education" during the 1970s. In September 1964, the Continuing Education Certificate program was initiated. In July 1975, the Executive Council approved the Continuing Education Department. Treadaway Hall was managed by Continuing Education as the "CEC" or Continuing Education Center. In May 1979 the Trustees approved the "concept of a School of Continuing Studies." However, from around 1978 until 1982, on-campus resistance emerged to its *de facto* status as a school. In addition, the program had to be subsidized by the University. Effective January 1, 1982, the program was eliminated and replaced with non-credit professional offerings organized as the Professional Development Programs Office. (For a history of the program and its development see the report authored by Robin Thedford, Director of the Professional Development Programs Office, 1993).

Non-credit Courses: The student records generated by the non-credit courses are arranged as part of UA 21 Instructional Special Programs.

Certificate Programs: Certificate Programs are described as accredited but non-degree. These include: Diaconal Studies, Urban Economics, Urban Government, Law Enforcement, Urban Research, Urban Sociology, Urban Administration

Cooperative Experiential Education Program (COEX), 1966, 1972-1990

International Education at StMU

Historical Note: Formal organization of initiatives in education across national borders begins at St. Mary's University by at least the 1960s. By the 1980s these initiatives are formally organized under the director of the Vice President for Academics. The instrument formulated to pursue these initiatives is various named: Humanities and Social Sciences Council on International Education (1985) an advisory committee which eventually became referred to as the International Education Committee (1988), then as the Strategic Initiatives in International Education Committee (1997). Finally, a Director of International Educational Programs (1998 June) was established with Ms. Minita Santizo as the first director. The international study tours that predated the formation of the International Education Committee include:

- o Biblical Study Tours of the Middle East sponsored annually by the Theology Department beginning 1972
- o Biennial Graduate Biblical Study Tour affiliated in 1984 with the American Schools of Oriental Research
- o Semester in England sponsored by the Department of English circa 1985
- o Semester in Austria sponsored by the Law School
- o Summer internship in a French, German or Spanish speaking country for MOS students
