- Description:** This is a collection of research on the subject of Henri Castro and his colonizing enterprise in Medina County, Texas. It includes an index of settlers obtained from various sources such as ship passenger lists, news clippings, family bibles, and Medina County court records. Facsimiles of the court documents from 1844 to 1898 are arranged in a separate series alphabetically by surname of litigant. In addition, there are documents and ephemera collected either as originals or in facsimile arranged alphabetically by subject headings. Included are 12 of the 27 shipping lists recorded by Henri Castro. The research notes accumulated by Dorothy Vance are contained in six handwritten notebooks. The notes concern biographies of the Alsatian settlers and an inventory of records held in various repositories about Medina County and its pioneers. A seventh notebook is from the H. E. Haas Collection accumulated by Dorothy Vance and included among her papers. Finally, the collection includes the typescript for an unpublished historical novel, *The Land of Promise*. There are 120 photographs intended for illustrating the novel.
- Processing:** An inventory was made of the collection upon its arrival at St. Mary's University during the summer of 1971. Over the years, different efforts to process the collection

have resulted in the loss of the original order which is suggested by the inventory. For example, at one point, the Medina County Court records were housed and described separately from the rest of the collection as if they were unrelated to each other. In addition, the 266 folders enumerated in the collection inventory at the time of its arrival at the repository, were later combined and reduced in number.

Chain of Custody: Frank X. Vance presented his wife's research to Saint Mary's University during the summer of 1971. Carmen Perry reviewed the material and prepared an inventory. A contract of gift was signed dated November 3, 1971.

Biographical Note: Frank X Vance (---) and Dorothy Lobitz Vance (1913-1962), residents of Hondo, Texas, were lawyers who practiced in Medina County. Dorothy Lobitz Vance was a native of Fort Logan, Colorado. Her father was in the military. She attended college in Denton and then Law School at the University of Texas graduating in 1936. She spent two years in the practice of law and then married. Frank Vance was born in Devine, Texas. His father was James William Vance whose ancestral home was on the Vance-Jackson Road in San Antonio. Frank Vance received a Bachelor of Arts degree from Texas State University at San Marcos, taught school for a year and then attended Georgetown University, Washington, D. C, where he received Ll. B and Ll. M degrees in the early 1930s. He moved to Hondo, Texas in 1937 to practice law. He taught at St. Mary's University Law School in 1937-1938. After marrying, the Vances practiced law together for about a year and a half. They had six children, five boys and one girl. In addition, she was active in the Archdiocesan Council of Catholic Women. Mrs. Vance spent approximately the last ten years of her life researching the lives of the original settlers of the Castroville colony. She wrote a history of Medina County that used some fictional characters as a device for making a story of it. During the last two years of her life, she made many attempts to find a publisher for it. But because her book was primarily a county history but told through some fictional characters, it qualified neither as fiction nor non-fiction. She died in 1962 at the age of forty-nine, unable to find a publisher.

Content Note: This list is arranged alphabetically by surnames. Surnames beginning with the same initial letter are combined into one folder. For each name there is a sheet of paper with abbreviated references to sources about that person such as court records, land surveys, shipping lists and notebook pages. Some of the sheets are handwritten, some are typed. There is no key to the abbreviations. For some surnames there are in addition inclusions of typescript notes and original documents that may have been added by library staff from other folders during past processing efforts.

Series Five: Dorothy Vance Correspondence, 1954-1961

Series Description: The correspondence is arranged within each folder by chronological order. The letters are about two subjects: either requests for research information or requests about writing and publishing her novel about Medina County history. Henri Castro left no known deposit of personal papers which required Mrs. Vance to see alternative sources as she explained in a letter to Professor William R. Hogan of Tulane University. Her text was completed by 1960 and her efforts turned to getting it published.

Series Six: *Land of Promise* Historical Novel

Historical Note: Despite much effort by Mrs. Vance and by her husband after her death, the novel remained unpublished. Literary agent Maurice Crane (letter of January 31, 1961) explained why the manuscript was not likely to be sold to a publisher: "This is primarily an historical account...not intent upon keeping the reader interested in the unfolding of a suspenseful and dramatic story, so much as in getting in all the details of the history. University presses do most of the history, but they shy away from fiction."

Series Seven: Medina County Court Records, 1838-1898

Series Description: In pursuit of her research, Dorothy Vance collected information from the records of the Medina County Court that concerned specific individuals of interest to her history of the Castro colonies. So the cases in this series, approximately 228, are a selection of the total. The records consist of original documents, mostly printed forms with the particulars of each case handwritten in 19th century script and spelling. How Dorothy Vance obtained these records is not known with certainty but she may have found them in the personal papers of a former county official (see page xi of the Hornbuckle Thesis).

Processing Note: The present arrangement of the individual cases in separate folders was made by Carmine Perry during the 1960s. The cases are not in original order but are arranged in alphabetic order by the name of the first litigant listed. Unfortunately, this means that the bulk are listed as "State of Texas." To facilitate research access, it is recommended that one use the Hornbuckle Thesis.

Hornbuckle Thesis: Mary Lou Hornbuckle's thesis compiled under the direction of Prof. Josephine Schulte, has as its purpose "to catalogue and index the Vance Collection for researchers." The thesis provides two indexes designated Index A and Index B. Index A is in order by case number followed by a summary of the type of case, the charge, date and page number where a transcription can be found. Index B is in alphabetical order by the names of litigants allowing the researcher to find the case numbers applying to each person named. Finally, Hornbuckle provides a typed transcription of the documents. Her work overcomes the obstacles in using the Vance collection that was occasioned by reordering the case files by name rather than number.
