**THE TEXAS COURT OF CRIMINAL APPEALS
HEARS ARGUMENTS ON CAMPUS
THURSDAY SEPTEMBER 18 AT 10:00 AND 11:00**

The Texas Court of Criminal Appeals is the highest court in the State of Texas that hears criminal matters. Because of the size of the Texas population, the volume of suits decided by the Court, and the visibility of Texas courts nationally, the Texas Court of Criminal Appeals is one of the most important tribunals in the country with respect to criminal law and procedure.

St. Mary's University School of Law is privileged to have the Court of Criminal Appeals hear arguments on campus.

The first argument, which begins at 10:00, involves a death-penalty appeal relating to the use of peremptory strikes against African-American veniremen. Classrooms 102 and 103 will be opened to the moot courtroom for this appeal, which will probably last about 40 minutes.

The second argument, which begins at 11:00, involves issues relating to driving while intoxicated and the validity of blood alcohol test results. The case will be argued for the appellant by St. Mary's Clinical Professor of Law Stephanie Stevens. All three classrooms will be opened to the moot courtroom for this argument, which will probably last about 40 minutes.

The briefs relating to the arguments are available on Docushare (you can log into Docushare directly, or there is a "useful link" in the library section of the law school website; once in Docushare, click "law students," then "court briefs").

Decorum. It is important for those attending the arguments to treat the members of the court, and those participating in its proceedings, with appropriate respect and deference. Such conduct is not merely good etiquette; it is an essential part of maintaining confidence in the courts and the administration of justice.

Guidelines for the Court of Criminal Appeals Arguments

1. For security reasons, backpacks and similar items are not permitted in the classrooms where the cases will be argued.
2. Persons attending the arguments may carry books with them but may not read while court is in session.
3. Cell phones, pagers or other electronic devices must be turned “off.”
4. The arguments may not be recorded, broadcast, or photographed.
5. Hats and caps, other than religious attire, may not be worn.
6. Eating, drinking, or chewing gum is not permitted.
7. All persons must be seated; entering or leaving the room once court is in session is not allowed.
8. Spectators must remain quiet while court is in session.

FACULTY NOTES

Dean Roberts spoke about the recent Supreme Court decision in Lawrence v. Texas. Dean Johnson talked about the role of the Supreme Court in shaping American Legal Ethics. The program was co-sponsored by the Federal Bar Association, the Bexar County Women's Bar Association, the San Antonio Bar Association, and the United States District Clerk for the Western District of Texas.

INSTRUCTIONS FOR USE OF LAPTOPS FOR EXAMS

Some (but not all) professors permit students to write answers to essay questions using a laptop. If a professor permits this option, and if a student plans to use a laptop, the student must register with ExamSoft. This must be accomplished before the beginning of the exam period (which begins this year on Monday, December 8). The website is www.examsoft.com/stmaryslaw.

On the exam date, students must set-up their computers in the Alumni Room of the Law Library 15-30 minutes in advance of the scheduled exam time. A full-time proctor is in the room. Students are then to report to the posted exam room to receive a copy of the exam and any special instructions. Students then return to the Alumni Room, retrieve a disk from the proctor, and boot up the system. The Alumni Room proctor times the exams and collects the completed exams from the students.

NPR'S "JUSTICE TALKING" TO TAPE SHOW IN MOOT COURTROOM

Annual Announcement

Each year, the professors shall publish an announcement in which they describe the topic of the paper for that year and the deadline for submission of the paper. The announcement may include other information about the contest as well.

General Rules

(1) In order to be eligible, the author of the paper must be a second- or third-year law student (one having completed at least two semesters as a fulltime student), and the paper must

concern the constitutional law topic chosen each year by the professors.

(2) The paper must be in printed form, and be at least 15 pages in length but no more than 25 pages, not including footnotes.

(3) The author shall not indicate his or her identity on the paper. All papers must be personally submitted before the deadline to Sister Grace Walle, and she shall make a notation on each paper of a number by which that paper is to thereafter be identified. (No paper shall be accepted after the deadline by anyone or for any reason.) In addition, Sister Grace Walle shall create a list including the names of the student authors and the numbers of their papers. This list shall not be given either to the law professors who judge the papers or to the Dean prior to the announcement of the winner of the contest.

(4) Unless declared otherwise in the announcement, the professors shall choose the three best papers and recommend those to the Dean. The professors shall use the following criteria: (a) depth of analysis, (b) research, and (c) quality of writing.

(5) The Dean shall choose the best of the three recommended to him by the professors, and the author of that paper shall be the winner of the \$1,000 award.

FALL 2003 DEAN'S LIST

The Dean's List is based upon those students whose semester grade-point averages rank in the top ten percent of the third-year class, in the top ten percent of the second-year class, or in the top ten percent of each first-year section. The *St. Mary's Law Journal*, now in its 35th year, tied for fourth in a list of legal periodicals most frequently cited in state and federal court cases over the seven-year period 1996-2003, according to a survey taken by Washington and Lee University. The survey ranked 938 U.S. and foreign journals. The *St. Mary's Law Journal* was cited 136 times – the same number as the *Georgetown Law Journal* – by courts in 31 states, the District of Columbia and two territories. Among those tribunals citing the work of the journal were 30 state supreme courts and three federal circuit courts. That number was surpassed only by the *Harvard Law Review*, *Columbia Law Review* and the *University of Chicago Law Review*.

This summer 36 new staff writers will be selected for membership on the law journal. All of the applicants must participate in the writing competition.
