### December 2011

The **International Association of Maritime Security Professionals (IAMSP)** and the **Center for Terrorism Law** will co-host a two-day international conference that focuses exclusively on the full realm of legal and policy issues associated with acts of piracy against commercial vessels. The conference is entitled: ***International Piracy and Maritime Security: Legal and Policy Issues for Business and Government***. Subject matter experts from legal, industry, government, and military will present detailed information to include: background of piracy; Somali piracy; civil suit liability; criminal liability; international maritime law; insurance coverage; use of force; terrorism; and training of security personnel and maritime employees. The conference will be held on 20-21 February 2012, at St. Mary's University, San Antonio, Texas.
