# Center for Terrorism Law

## Monthly Activity Report

### February 2012

1. Professor Addicott's book chapter entitled: *Is the Use of Coercive Interrogation or Torture Permissive and Effective as a Counter-terrorism Method?*, was published in **Contemporary Debates on Terrorism** (Richard Jackson & Samuel Justin Sinclair, 2012).

2. The Center for Terrorism Law hosted a one day seminar to discuss two pressing issues in the continuing War on Terror. The seminar was entitled: *Rules of Engagement and Wounded Warrior Support*. Leading subject matter experts from legal, industry, government, and military presented detailed information on how self-imposed rules of engagement operate both in the realm of combat operations and new technology innovations. The case of Marine Lt. Joshua Waddell served to illustrate how overly restrictive rules can lead to injustice to our troops in the field.

In turn, the seminar also highlighted myriad issues faced by our wounded warriors returning from combat. The seminar was held on **February 21, 2012**, in Conference Room A at **St. Mary's University**, San Antonio, Texas. The event was free and open to the public.

3. One of the primary missions of the Center for Terrorism Law is to assist our military members wrongfully accused of violations of law while acting in the course of their duties in combat. Currently, the Center is actively working with Marine Lt. Joshua Waddell (stationed in Afghanistan) to defend him against spurious accusations by his Company and Battalion Commanders that he committed violations of combat rules of engagement in the course of a combat operation. Lt. Waddell was relieved of his position as Executive Officer and given a career ending officer fitness report. The case has received national attention.
