## Monthly Activity Report

### March 2012

1. One of the primary missions of the Center for Terrorism Law is to assist our military members wrongfully accused of violations of law while acting in the course of their duties in combat. Currently, the Center is actively working with Marine Lt. Joshua Waddell to defend him against spurious accusations by his Company and Battalion Commanders that he committed violations of combat rules of engagement in the course of a combat operation on November 1, 2011. Lt. Waddell was relieved of his position as company Executive Officer and given a career ending officer fitness report. The case has received national attention. The Center for Terrorism Law is assisting in a Congressional Inquiry by the office of **Texas Senator John Cornyn**, appealing the administrative actions through military channels, and assisting members of Congress draft legislation to establish an oversight board for military personnel accused of violating Rules of Engagement.
