## Monthly Activity Report

### December 2012

1. The Center for Terrorism Law provides non-legal informational assistance regarding issues of national importance affecting our military and law enforcement personnel who may be unjustly treated as a consequence of the performance of their official duties. Currently, the Center for Terrorism Law has helped bring national attention to the plight of a Coast Guard officer regarding the Department of Homeland Security and the US Coast Guard. The story was covered in detail on the front page of the Washington Times on December 23, 2012 (see below).

Professor Addicott's detailed law review article entitled: *Rightly Dividing the Domestic Jihadist from the Enemy Combatant in the War Against Al Qa'eda – Why it Matters in Rendition & Targeted Killing*, has been submitted for publication to the Case Western Reserve Law School, Cleveland, Ohio. Addicott participated in a roundtable debate on this topic at the Frederick K. Cox International Law Center War Crimes Research Symposium on 7 September 2012, in Cleveland, Ohio.
